Instructions and Changes

The **Elmore County Community Foundation** (ECCF) is a public foundation which links charitable resources with community needs and opportunities. Each year, the Foundation awards grants to nonprofits offering projects and programs in Elmore County that, in the opinion of ECCF's Advisory Committee, will improve the quality of life in our community.

While many factors are considered, priority is given to proposals that meet the following criteria:

- Programs that address issues affecting Elmore County;
- "Seed" grants to initiate promising new projects addressing underlying causes of community problems;
- Expanding programs representing innovative and efficient approaches to serving community needs and opportunities;
- Programs that maximize resources and leverage other monies;
- Projects reflecting the cooperative efforts of multiple agencies within the community;
- Programs that can demonstrate funding plans for the continuation of the project beyond initial funding by the ECCF.
- **Grants are not awarded to: Individuals, Fundraising Events, or Capital Campaigns.**

For 2012, the maximum grant award is \$2500, with the average grant ranging from \$500 to \$1000. Applications will be accepted online, and the submission deadline is March 9, 2012.
