

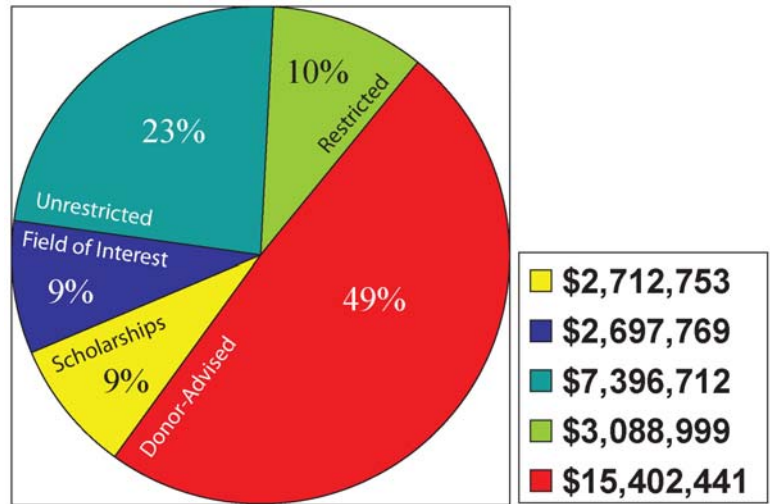

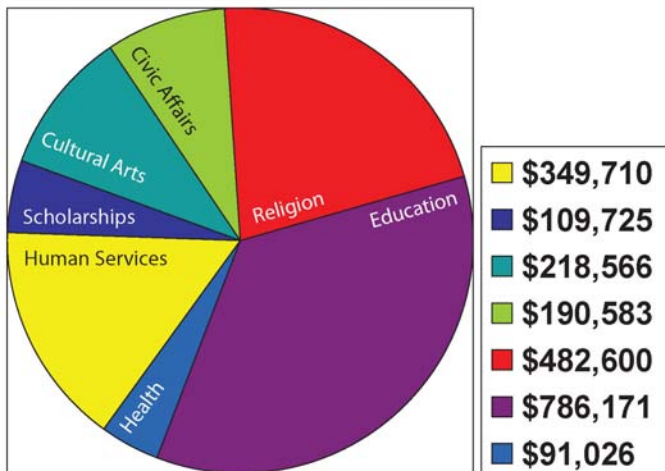
## Total Foundation Funds
